Vendors must comply with all COVID19 rules defined here, which follow those put forth by the Washtenaw County Health Department\* and Michigan's State Orders & Directives\*\*. As these are subject to change by June 4<sup>th</sup>, vendors will be asked to reaffirm their compliance with the current rules and regulations at the time when checking in for the event.

#### **Vaccinations**

# Physical Distancing

Physical distancing is encouraged. Physical distancing means avoiding working in close groups and maintaining distance (approximately 6 feet or 2 meters) from others when possible. Strategies include:

- Increasing physical space between employees at the worksite;
- Increasing physical space between employees and customers (e.g., table partitions, ground markings at checkout, limitations on the number of people allowed at a vendor at a time);
- Set up vendor space to minimize or eliminate customers from handling products or other items until they have finalized a purchase
- If selling products, use technology to encourage pre-sales, and reduce face-to-face sales interactions.

### Self Screening, Monitoring, Quarantine, and Isolation

All organizers, attendees and vendors are recommended to self-screen with the following questions:

- Do you have symptoms of fever, cough, shortness of breath, sore throat, chills, repeated shaking with chills, muscle pain, headache, diarrhea or new loss of taste or smell that may not be attributable to regular symptoms related to a chronic medical condition? Yes/No
- Have you had close contact in the last 14 days with an individual diagnosed with COVID19? Yes/No
- Have you travelled internationally or outside of Michigan in the last 14 days, excluding commuting from a home location outside of Michigan? For purposes of this screening, commuting is defined as traveling between one's home and work on a regular basis. Yes/No

If anyone answers "yes" to any of the screening questions, they should isolate or quarantine following the latest CDC guidelines:

#### **Protective Masks**

Members of the general public, 2 years or older, should wear the most protective mask available that that fits well, and that will be worn consistently. Cloth face coverings with multiple layers, surgical (procedure) masks, KN-95 respirators, or N-95 non-surgical respirators are options.

Vendors are encouraged to clean or disinfect high-touch surfaces at least once a day or as often as determined is necessary. It is recommended to wash your hands with soap and water for 20 seconds after cleaning and as necessary. Be sure to wash your hands immediately after removing gloves.
