

#### More Habitat Added to MAEAP

This past month, Pat Garrett of Scio
Township was able to have her habitat
verified in the Forest, Wetland and Habitat
system under MAEAP. Though the habitat
is just a few acres it contains unique
features such as a small vernal pool which
is extremely important to the breeding of
amphibians. Buckthorn has been an issue
in the habitat, but Pat has worked hard at
removing the invasive species, opening up
the canopy in the process. A defining
feature of the habitat is the large bur oak
that towers over not only the habitat but

also the nearby house. Estimated to be a few hundred years old, the offspring of this bur oak can be seen throughout the habitat, dwarfed by its mother.

#### **Resources for Grid Soil Sampling**

The WCCD has funds for farmers interested in upgrading their soil testing regiment through the STRAND program. The funds will go towards grid soil testing. This testing will allow for more accurate nutrient level readings for one's field. This may save the farmer money on fertilizer should nutrient levels turn out acceptable in parts of a field. Farmers must reside in the River Raisin Watershed or Stony Creek Watershed and must be farming field crops.
