### Vendor Requirements

- All vendors selling live plant materials must have a current Nursery Stock Dealer license through the State of Michigan.
- All live plants or seeds must be native to Michigan. A list of species should be included with application.
- All vendors must provide proof of insurance prior to the event, submitted with application.

All vendors that plan to attend must fill out an application. Businesses that plan to promote paid services or sell materials must pay a fee of \$25 for the day, due the day of the event. Checks payable to Washtenaw County Conservation District.
